1. Harion Municipality, Office of the Municipal Executive, Harion, Sarlahi invites sealed or electronic bids from eligible bidders under National Competitive Bidding procedures. Bidding is open to all eligible Nepalese Bidders.
2. A complete set of Bidding Documents may be purchased at office hours from the Harion Municipality office, Harion, Sarlahi, by eligible Bidders on submission of written application, along with duly attested copies of Bidder's registration, VAT registration and Tax clearance certificate (**Valid for Fiscal Year 2075/76**), Joint venture agreement (in case of JV) and upon the payment of a non-refundable fee as mentioned in the table below within the office hour on or before **20th Falgun**
3. Bidding Documents can be downloaded from e-GP system in www.bolpatra.gov.np/egp. Interested bidders shall register in the e-GP System and deposit the cost of bidding documents Rs 3000.00 in the following bank.

5. Pre-Bid Meeting shall be held at Harion Municipality Office, Harion, Sarlahi at 2:00 hour on **20th day from first day of notice published.**
6. Electronic Bids must be submitted through www.bolpatra.gov.np/eGP on or before 12:00 hr on 21st Falgun or the purchased bid documents shall be sealed in an envelope addressing to the office mentioned above, indicating name of the contract, contract identification number, name of the bidder's firm and its detail address. The office shall not be responsible for any miscommunication in case of incomplete information about firm's address. The Bid must be submitted at Harion Municipality on or before 12:00 hr 20th Falgun.
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 hour on 21st Falgun at Harion Municipality, office of the Municipal Executive, Harion, Sarlahi. Non-attendance of any or all of the Bidder's representatives shall not hinder the opening of the bids. Bids must be valid for a period of as mentioned in table below after the date of bid opening.
8. Bids must be accompanied by a Bid Security of minimum amount specified in table below either in the form of bank voucher confirming cash deposit in deposit account no. as specified above or a bid security (unconditional bank guarantee) issued by "A" Class commercial Bank as approved by Nepal Rastra Bank. The Bid Security shall be *valid for 30 days* beyond the bid validity period. **Bidder must clearly quote the contract name and contract number in Bid security form (Bank guarantee) otherwise will cause disqualification of Bidder.**
9. Bidders can bid as a single contractor or in the form of Joint Venture of maximum of three contracting firms.
10. Bidders are advised to visit the site and assess the actual site condition before submitting the bids at their own cost.
