1. Harion Municipality has allocated funds towards the cost of Construction of Shopping Complex and intends to apply part of the funds to cover eligible payments under the Contract for NCB-17/075/76. Bidding is open to all eligible as per Section V. of bidding document..
2. Harion Municipality, Office of Municipal Executive, Harion Sarlahi invites electronic bids from eligible bidders for the construction of Shopping Complex under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

*Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:
NRs. 250 Million

*Minimum Work experience of similar size and nature: 3 projects, value of each to be not less than NRs. 110 Million

3. Eligible Bidders may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder must submit their bid electronically by download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at Office of Harion Municipality, Sarlahi at 11:00AM, 2076/01/10.
6. Bidders must submit electronic bids only through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM on or before 2076/01/22. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2076/01/22 at the office of Harion Municipality, Sarlahi. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 50,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
